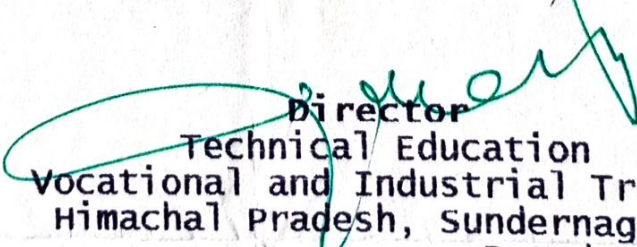

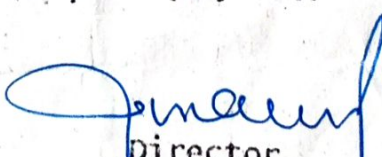

Subject: Affiliation of Units/Trades of ITIs /ITCs with NCVT-regarding

Sir,

The Standing Committee Inspection Reports (SCIRs), Departmental Inspection Reports (DIRs) and Supplementary Inspection Reports (SIRs) forwarded by you, were put up before the members of the Sub-Committee of National Council for Vocational Training (NCVT) dealing with affiliation in its meeting held on **10.6.2005** at DGE&T Hqrs., New Delhi for its consideration and approval.

The Committee examined various affiliation cases and accorded approvals in deserving cases.

A copy of the statement containing the names of ITIs /ITCs/Trades/Units in respect of your State which have been approved/rejected along with remarks indicating the conditions for affiliation etc. duly signed is enclosed. On the basis of this you may issue the affiliation orders to the Management of the concerned ITIs/ITCs which have been approved whereas to the others institutes affiliation orders be issued after the stipulated conditions/action as stated in the remarks column for compliance. The conditions stated for grant of affiliation should be clearly conveyed to the respective institute stating that the deficiencies under Remarks column are to be made up. The other conditions of affiliation, if any, are to be complied with before the affiliation order is issued by you.

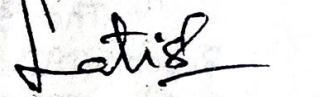
Your attention is also drawn to the effective date (i.e. SCIR/DIR/date) of the trades/units kept "under consideration-(UC)". The trainees admitted in the trades/units kept as "UC" may be allowed to appear in the All India Trade Test for Craftsman provided they have completed the training period from the date the trade/unit has been kept UC i.e. the trainees admitted in the academic session from which affiliation has been kept under consideration and not of earlier batches. However, the Supplementary Inspection Reports (SIR) in respect of all such UC cases should be submitted within three months positively, so that these UC cases can be put before next meeting of the Sub-Committee of

NCVT for its consideration /approval failing which UC stands withdrawn . In case the institute fails to make up the deficiencies within the prescribed time limit of three months, it will be responsibility of the concerned State Director to inform the institute the UC stands withdrawn and fresh Standing Committee Inspection /Departmental Inspection depending upon the case is required to be done in such cases under intimation to this Directorate General.

It may please be noted that, the cases, which have been rejected in variably, require fresh standing committee inspection / Departmental inspection depending upon the case for grant of affiliation of trades / units. Accordingly institute may please be advised.

You are also requested to quote DGE&T file number as indicated below the institute's name in the list enclosed, while making future correspondence related to respective ITI's/ ITC's.

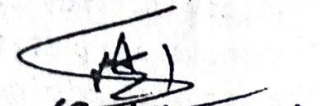

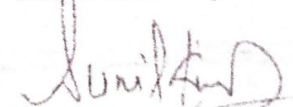

Sir/Madam,

Please find enclosed herewith a copy of minutes of 5th meeting of Standing Committee on Accreditation and Affiliation (SCAA) held on 16th August to 18 August, 2022 along with its annexures. Agenda item-wise implementation orders will be issued subsequently.

2. The decision of the committee / these minutes shall be read and construed in conjunction with the office order(s) which would be issued and signed separately by the competent authority.

3. The list of ITIs annexed in Annexure-2 (a total of 152 new Accreditation/Affiliation proposals for existing and new ITIs) which have remarks "**Not Recommended/Rejected**", or which have been asked to "**remove the deficiencies**" shall follow the process/procedure defined below as per their remarks:

3.1 For the ITIs which have remark "**Not Recommended/Rejected**", may remove the deficiencies as mentioned in the Minutes of Meeting and resubmit their case to concerned RDSDE within one month from the date of issue of this Minutes of Meeting. RDSDE will further review the cases in consultation with the State and submit a report with their concluding remarks to the Director (TC).

3.2 For the ITIs which have the remark "**remove the deficiencies**" may remove the deficiencies within the stipulated timeline as mentioned in the Minutes of

Meeting and further submit requisite documents through RCI/SDE with recommendation from the State in stipulated timeline to comply with the 5th SCAA remarks as mentioned in Minutes of Meeting. In the event of any ITI failing to do so, its affiliation proposal shall be "Not Recommended", and further would fall under point 3.1.

Further, all the compliance reports must be sent to Director, TC only on below mentioned e- mail id with subject tag line-**Compliance of 5th SCAA Meeting <State Name><ITI Name>**.

4. Any ITI who are aggrieved with the decision of the SCAA, may register their grievances to Grievance Redressal Cell, TC section, established as per office order DGT-HC044/18/2021-O/o Dir (TC) dated 16.08.2022 , within 07 days, at the following Google-form link: <https://forms.gle/7RhPDDHvuG39jggj7>.

5. It is to be noted that if any of such case forwarded by the Grievance Redressal Cell gets recommendation, affiliation session will be decided as per DGT academic calendar, whereas the ITIs who does not fulfill the conditions within the stipulated timeline would be "Not Recommended/Rejected" and finally shall be deemed rejected and will have to apply afresh. No further representation shall be accepted under any circumstances after the closure of the given timeframe.

6. The final decision on the applications shall be subject to fulfillment of conditions mentioned in the office order(s) read with Minutes of Meeting, which further shall be taken according to the established norms and principles and, following due process of law.

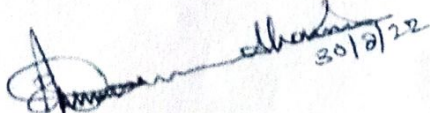
